Given the emerging of COVID-19 positive cases in the district and having limited isolation facilities under the jurisdiction, the Task Force has decided to set up criteria for the inclusion of the cases to be admitted into Non-Hospital Isolation facilities being initiated by the Dzongkhag Task Force.

The Task Force has come up with the following criterions for isolating positive cases to the Non-Hospital Isolation facilities:

1. Positive healthcare workers
2. Positive cases sharing toilet and other essential facilities with other groups
3. Households of the positive cases having toilet outside in the clustered areas
4. Positive cases having vulnerable population in the household
5. Positive cases from an isolated location not possessing close contacts to anyone nearby shall be considered for not lifting

In addition to the decisions made on the setting of above criterions, the following issues were also discussed and endorsed.
